CLAUSE 3 – INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, implication, estoppel, or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights, and designs) of the other Party.

CLAUSE 4 – VALIDITY

- 4.1 This Agreement will remain valid until it is expressly terminated by either Party on mutually agreed terms, during which period both Parties will take effective steps for implementation of this MoU.
- 4.2 Both Parties may terminate this MoU upon 30 calendar days' written notice. In the event of termination, both Parties shall discharge their obligations up to the date of termination.

CLAUSE 5 – RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that Government College and Know Your CTC (KYC) by Unified Mentor Private Limited are acting under this MoU as independent entities, and the relationship established under this MoU shall not be construed as a partnership.
- 5.2 Neither Party is authorized to use the other Party's name in any way, to make any representations, or to create any obligation or liability, expressed or implied, on behalf of the other Party without prior written consent.

5.3 Any divergence or difference derived from the interpretation or application of this MoU shall be resolved by arbitration between the Parties as per the Arbitration Act, 1996. The place of arbitration shall be at the District Headquarters of the First Party. This undertaking shall be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Punjab.

6. Placement Support Clause

Know Your CTC (KYC) by Unified Mentor Private Limited agrees to provide placement and internship opportunities to the second-year and third-year students of Government College, Hansi for a period of three (3) years from the date of execution of this Memorandum of Understanding (MoU).

During this period, Unified Mentor Pvt. Ltd. shall extend its support by:

- 1. Sharing relevant job and internship opportunities with eligible students of **Government** College.
- 2. Facilitating participation in placement drives, training programs, and recruitment processes conducted by Unified Mentor Pvt. Ltd. or its partner organizations.
